

## Gun Lake Tribal Gaming Commission Vendor License Application Form

## License Application Instructions

1. Submit the completed application and all additional required documents listed below.
2. All principals, service technicians and/or other individual of the firm that will be on the premise of the Gun Lake Casino must also fill out an Individual Gaming Application and submit it with their Vendor Application. If these individuals are located outside of the United States then they must provide a criminal and credit history with their individual gaming application submission.
3. Submit the initial vendor licensing fee of $\$ 2,500$ (gaming vendor) or $\$ 1,000$ (non-gaming vendor). Payment can be made by money order, cashier's check, or company check only and made payable to the Gun Lake Tribal Gaming Commission.
4. Type or print legibly, in black ink, all information requested on the application. If a question does not apply, indicate "N/A" (Not Applicable).
5. Applications that are incomplete or that are missing required documents will not be accepted.
6. Provide additional documents as requested below.
7. All Notary Forms included in the application must be signed in the presence of a notary public.

This Gaming License Application is an official document of the Gun Lake Tribal Gaming Commission. Any misrepresentation or failure to disclose information requested may be grounds for denial, suspension, or revocation of a license. Applicant may be asked to provide additional information as determined by the Gun Lake Tribal Gaming Commission.
It is important not to misstate any response or omit any material fact, as each statement made in this application is subject to verification. Any corrections, changes, or other alterations must be initialed and dated by the applicant. Any additional pages must be initialed by the applicant in the lower right hand corner.
Please type or print legibly in black ink a complete response to each question on this application. If additional space is needed, use a separate page; indicate the corresponding question number for each response. Applications that are not complete may be returned for additional information.
Use of Information: The information requested in this application will be used to determine the eligibility of the business for a vendor license. The information will be used by the Gun Lake Tribal Gaming Commission and staff who have need for the information in the performance of their official duties. The information may be disclosed to appropriate federal, tribal, state, local, or foreign law enforcement and regulatory agencies when relevant to civil, criminal, or regulatory investigations or prosecutions, or when required by the Tribe or the National Indian Gaming Commission in connection with the issuance or revocation of a vendor license, or investigation of activities while associated with a Tribe or a gaming operation. Failure to consent to the disclosure indicated in this notice may result in the Gun Lake Tribal Gaming Commission being unable to issue a license.
PRIVACY NOTICE: In compliance with the Privacy Act of 1974, the following information is provided: Solicitation of the information on this form [your application for a gaming license and any renewal thereof] is authorized by 25 U.S.C. 2701 et. seq.
